- Living Will, Medical and General Durable Power of Attorney (New 2010 version)
- Will (select the will that applies below – select only ONE)
 - Single person with NO children
 - Single person that leaves everything to ONE child
 - Single person that leaves everything equally to children
 - Married couple with NO children leaving everything to each other
 - Married couple that leaves everything to each other first then to ONE child
 - Married couple that leaves everything to each other first then equally to children
 - Married couple that leaves everything to each other first then equally to children from prior marriages
